## **Receives NALCP 2017 Best Practices Award**

October 25, 2017 – Commissioner Teri L. Quimby of the Michigan Liquor Control Commission, and current 2<sup>nd</sup> Vice-President of the National Conference of State Liquor Administrators, was awarded the 2017 Best Practices Award by the National Association of Licensing Compliance Professionals at the NALCP Annual Conference in San Diego, California last week. Commissioner Quimby has an extensive background in state and local government, has acquired considerable regulatory experience in environmental, utility, commerce issues, and alcoholic beverage issues, and has been licensed to practice law in Michigan and Illinois for over 25 years. As a graduate of Michigan State University's James Madison College (with a major in Justice, Morality and Constitutional Democracy, and a minor in German) and Western Michigan University's Cooley Law School, she is committed to the pursuit of good public policy.
