Please join moderator, Nicholas Bergman of Buchman Law Firm, and his esteemed panelists – Director Gerald Takase, County of Hawai'i Department of Liquor Control, Director Debbi Beavers, Kansas Alcoholic Beverage Control Division, Kimberly Frost of Martin, Frost & Hill, Austin, TX, and Rebecca Stamey-White of Hinman & Carmichael LLP, San Francisco, CA – for an invigorating discussion of professional responsibility. Reference will be made to ABA Model Rules on Confidentiality (Rule 1.6), Conflicts (Rule 1.7), Zealously Represent (Rule 1.3), Organization as Client (Rule 1.13) as we work through these ethical dilemmas together with audience participation. We anticipate 1-hour CLE ethics credit will be earned for attending.
