Presenter Biographies

JACOB APPELSMITH of Sacramento is the Director of the California Department of Alcoholic Beverage Control. Jacob graduated from Middlebury College in Vermont in 1985, and from UC Berkeley's Boalt Hall School of Law in 1988. While at Boalt, he worked as a student clerk to Justice Allen Broussard on the California Supreme Court.

Jacob began his career as a lawyer with Pillsbury, Madison & Sutro in San Francisco, where he worked for six years as a commercial litigator. Jacob joined the California Department of Justice, Office of the Attorney General, in 1994, and in 2008 became a Special Assistant to Attorney General Jerry Brown on matters pertaining to law enforcement and the criminal justice system. He also served as AG Brown's Chief of the California Bureau of Gambling Control.

In January 2011, Jacob joined Governor Brown's administration as a Senior Advisor to the Governor and the Director of the Department of Alcoholic Beverage Control. In these roles, he served as the Governor's negotiator for tribal-state gaming compacts and tribal land-use matters, advised the Governor on a range of issues from public safety to veteran's affairs, and was responsible for criminal enforcement and regulation of California's 90,000 licensees in the alcohol industry.

Jacob was appointed Chief Campus Counsel for the University of California, Davis, in September 2013. In this role, he was responsible for all aspects of the university's legal affairs, including its \$3.5 billion budget, its 35,000 students, its hospital and health system, and its operations throughout California, the United States, and the world. In June 2017, Jacob returned to Governor Brown's administration as Director of the Department of Alcoholic Beverage Control and as an advisor to the administration.

STEVEN BARKER is the Deputy Director and General Counsel of the ABLE Commission, and has served the Commission since 2015. Following two years in private practice, Mr. Barker began his public service career as an Assistant General Counsel for the Oklahoma Tax Commission supervising a team of attorneys focused on the collection of sales, mixed beverage, and withholding taxes. Immediately prior to joining the ABLE Commission, Barker served as an Assistant Attorney General under E. Scott Pruitt providing legal counsel to a variety of state agencies. Steven and his wife Shauna reside in Edmond, Oklahoma with their three children.

DEBBI BEAVERS joined the Kansas ABC in January 2004. In 2010, she was promoted to licensing manager and promoted to operations manager in 2015. She was appointed interim ABC Director in 2016 and was confirmed by the Senate in January 2017. Debbi is the first female director since the inception of ABC in 1949 and serves at the pleasure of the Secretary of Revenue.

Debbi's priorities for the ABC Division are to regulate the industry consistently, provide excellent customer service and increase compliance with liquor laws through education and training.

Prior to joining the Kansas ABC, Debbi lived in Missouri and worked in the private sector as a Medicare compliance analyst and also a social services director. Debbi studied at Missouri Western State College and has an associate's degree in travel.

Mr. Halfacre, having served as Director of the New Jersey Division of Alcoholic Beverage Control, has a deep knowledge and understanding of alcohol beverage laws and regulations. This experience, added to Mr. Halfacre's background in financial, real estate and political matters, enables him to provide valuable counsel to the Association Members.

Mr. Halfacre was appointed as Director of the Division of Alcoholic Beverage Control by Governor Chris Christie. He began his work as Acting Director on February 6, 2012 and, after New Jersey Senate confirmation, was sworn in as Director on March 30, 2012. While at the ABC, Mr. Halfacre oversaw the implementation of New Jersey's Direct-to-Consumer wine shipping statute and the expansion of privileges for wineries, craft breweries and craft distilleries. Mr. Halfacre was also responsible for the planning and roll-out of the ABC's electronic licensing system, the first major overhaul in the ABC's technology in over 20 years.

Prior to leading the ABC, Mr. Halfacre served as mayor of Fair Haven. He took office in the Monmouth County borough in 2007 and won reelection in 2010. As mayor of Fair Haven, he lowered property taxes every year from FY2008 to FY2012, the only municipality in the state to accomplish that feat. He was also a candidate for the United States Congress in 2010.

In addition to his role as mayor, Mr. Halfacre ran his own law practice, where he specialized in transactions, including purchases, sales and refinancing of real estate, small business transactions and transfers of ABC licenses. He also served as a municipal attorney for several area municipalities.

Mr. Halfacre is a member of the New Jersey State Bar Association, the Monmouth Bar Association and is a Trustee of the Monmouth Bar Foundation.

Mr. Halfacre attended law school at the University of Dayton, where he was a member of the Mock Trial Team, and received his undergraduate degree from the Florida State University, where he was Captain of the Men's Varsity Swim Team.

TRAVIS HILL was appointed as Chief Executive Officer of the Virginia ABC Authority by Governor Ralph Northam in January 2018. As CEO, Travis Hill serves as the head of the ABC Authority and works with the appointed five-member Authority Board to set the course and strategic objectives for the Authority. Prior to his appointment as CEO, Hill served as Virginia ABC's Chief Operating Officer after being appointed to that position by Governor McAuliffe in October 2014. During his time as COO, Hill focused on increased revenue, a modernization of business practices and agency infrastructure and enhancing regulatory service provided by the Bureau of Law Enforcement. He also guided the smooth transition of Virginia ABC from an agency to an authority structure. Before arriving at ABC, Hill previously served as Deputy Secretary of Agriculture and Forestry, having been appointed by Governor McAuliffe in January 2014 after serving in the same capacity under Governor McDonnell since July 2011. Prior to that, Hill worked eight years as an attorney in the Richmond office of Williams Mullen representing a wide variety of clients before the Virginia General Assembly, the State Corporation Commission and other regulatory bodies, including Virginia ABC. Hill received both his Bachelor of Arts and Juris Doctor degrees from the University of North Carolina at Chapel Hill.

Steve is a nationally sought speaker on alcoholic beverage law issues and has been a frequent speaker at National Alcohol Beverage Control Association (NABCA) national legal symposiums; National Conference of State Liquor Association (NCSLA) national and regional conferences; CLE International's Wine, Beer & Spirits Law annual conferences, PLI's Alcohol Law programs, and Kentucky Bar Association annual conferences.

From 2004 to 2010 Marks was president of his own public policy and public affairs consulting business, *The Marks Network*. In 2013, he returned to state government service as a policy advisor within the Chief Operations Officer's Office, Oregon Department of Administrative Services.

Marks earned his undergraduate degree and Master's Degree in Public Policy, Planning and Management from the University of Oregon.

In this capacity, Thomas collaborates with other state regulatory officials across the eleven member states within the southern region on current issues relating to state regulation of alcoholic beverages.

Thomas is a member of The Florida Bar. Prior to joining the Division, he represented clients in private practice across a broad portfolio of governmental and regulatory legal matters. Before practicing law, Thomas served as an on-the-record spokesperson and media liaison for Governor Jeb Bush and Governor Charlie Crist in Florida. He also served in fellowships with the Governor's Office of Policy and Budget and the Economic Affairs Committee of the Florida House of Representatives.

Thomas earned a Bachelor of Science degree from the University of Florida and a Juris Doctor degree from the Florida State University College of Law, where he served as President of the Moot Court Team.
