For the first time, buyers of wines and spirits will be empowered to see the proof of authenticity and provenance history of a bottle prior to making a purchase.

Today, Ms. Downey is considered one of the top women in wine and can currently be seen combatting counterfeits in the Netflix film, *Sour Grapes*.

PAMELA S. ERICKSON is a passionate leader on alcohol policy issues. Currently, she owns Public Action Management which operates an education campaign for a "Healthy Alcohol Marketplace." She served the State of Missouri as a criminal investigator for several years before being promoted to lieutenant and accepting a position with the Patrol's Professional Standards (internal affairs) Division. Her last assignment before she retired was as Assistant Director of the Patrol's Training Division.

On November 1, 2017, the day after her retirement from the Highway Patrol, Dottie took over the helm at Missouri Alcohol and Tobacco Control as the State Supervisor. Dottie strives to bring a style of leadership to ATC that encourages positive innovation and empowerment. After staffing at ATC was drastically cut in the late 2000's, ATC went through ten long, lean years, but has finally begun to rebuild, with district offices in Kansas City, St. Louis and Springfield, in addition to the main location in Jefferson City. Dottie's position requires a gubernatorial appointment and she serves at the behest of the governor, now Governor Parson, with confirmation by the Missouri Senate. She plans to stay at ATC as long as the Governor will have her or until November 2022, whichever comes first. Dottie will then retire to her lake house in Alabama.

He is an attorney who holds an AV Preeminent rating from Martindale-Hubbell, which represents the highest ranking given to a lawyer by his peers for both professional excellence and ethical conduct. He formerly chaired the Criminal Law and Criminal Justice Committee of the Nashville Bar Association and had over 13 years of criminal trial experience before joining the ABC.
