How did the pandemic change consumer patterns in actual numbers? Will these changes stay? This session is only 30 minutes long and will set the stage for the remainder of Day 2's panels and should not be missed!

COVID MASH UP

What would a post-2020 alcohol beverage industry conference be without a COVID panel?
