Daniel Okrent To Be Keynote Speaker When

Anthony, Billy Sunday, William Jennings Bryan, Sam Bronfman, Pierre S. du Pont, H. L. Mencken, Meyer Lansky, and the one and only Mabel Walker Willebrandt, considered by many to be the most powerful woman in the country during Prohibition.
