As the costs associated with overconsumption and youth access continue to rise, some state Regulators wonder whether their respective agencies should take a more active role in determining the suitability of such packaging within their respective states.

Do states have an obligation to play a more significant role in the packaging approval process, and if so, what legal obstacles would those states face when enacting more stringent packaging requirements?
