## NCSLA 2013 Annual Conference Presents "Beyond Blue Laws: Hot Legislative Issues Seeking to Bring States into the 21<sup>st</sup> Century"

The National Conference of State Liquor Administrators, Incorporated (NCSLA) will assemble June 24-28<sup>th</sup> on the island of Oahu at the Sheraton Waikiki Resort in Honolulu, Hawaii for its 2013 annual meeting and conference. Serving as conference host is the Honolulu Liquor Commission, and Administrator Greg Nishioka.
